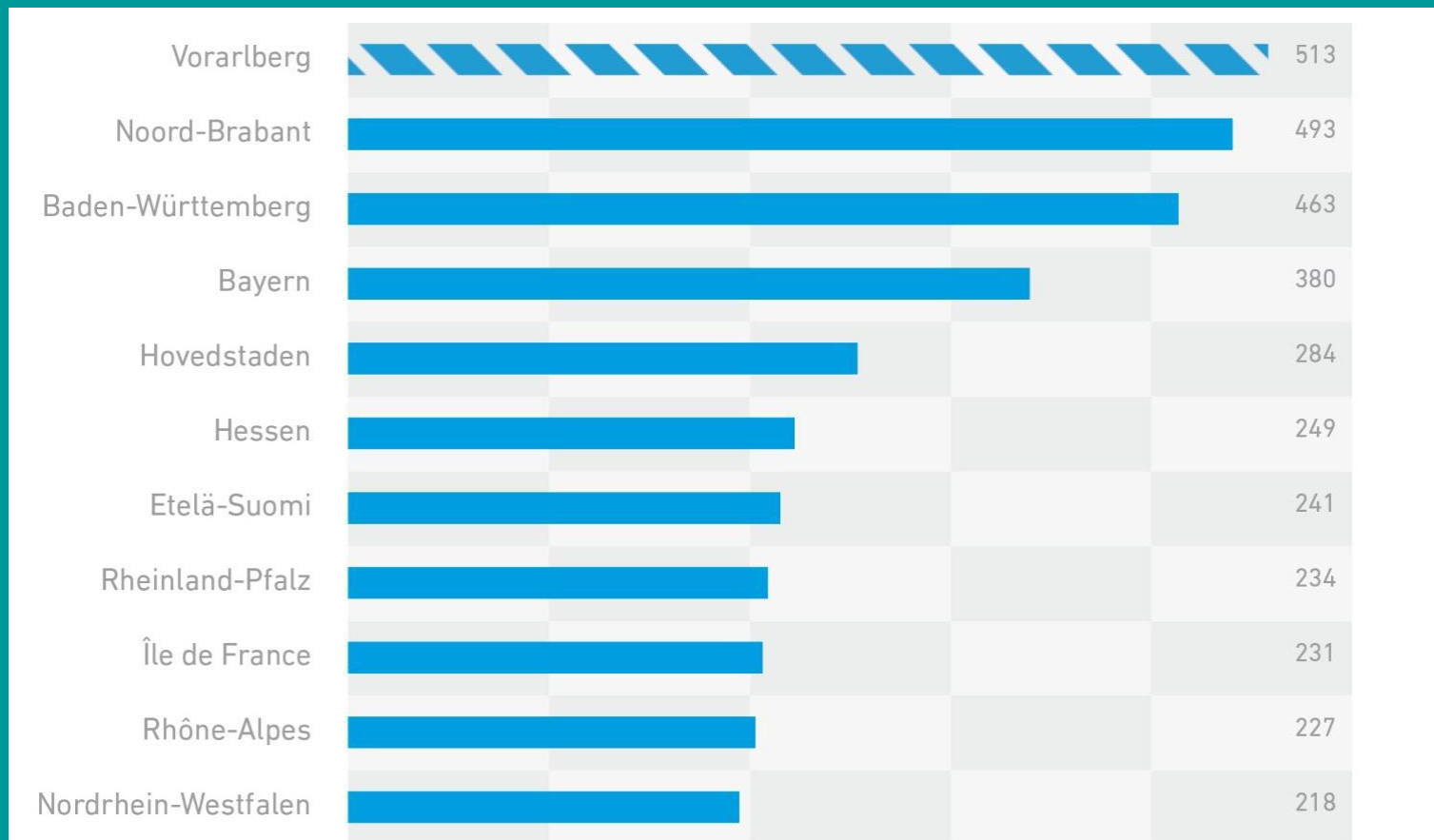

Economic performance of Vorarlberg

About 60% of produced goods are exported:

- 25% ironware and metallgoods
- 23% caldron, machinery and apparats
- 9% foodstuffs and drinks
- 8% electrical machines and appliance
- 8% textiles and clothes
- 7% plastic materials, chemical products
- 5% furniture and luminaire
- 16% other (electricity, paper..)



What is ECOPROFIT

- „**EC**Ological **PRO**jekt **F**or Integrated clean**T**echnology“
Goal of the method: optimized use of resources and energy, as well as decrease and prevention of garbage and emissions
- municipal or regional cooperative project
- developed by the town of Graz (Styria) beginning of the 1990 in cooperation with research community STENUM GmbH (meantime registered trademark)

ECOPROFIT® Austria

- **Projekt history:**

- 1991 first pilot training course in Graz
- 1993 first regular training course in Graz
- 1996 ECOPROFIT- comes to Vorarlberg (city of Dornbirn)
- 1997 5 training courses at once (with 40 enterprises) at different townships
- 2013 more than 150 enterprises are certified and active in Vorarlberg

- **Vorarlberg:**

- since 1996 more than 250 enterprises got through the training courses www.vorarlberg.at/oekoprofit

Benefits for the townships

- Increase of quality of life for the people living in the townships / regions due to reduction of emissions
- Increase of quality of environment in the region with benefit for tourism
- Positive image for the township at the enterprises and role-model approaches at neighboring communes
- Consolidation of the partner relations between enterprises and communes
- Efficient and cheap relief of environment due to higher efficiency of resources
- Job preservation due to successful companies
- Support of innovative companies instead of expense for cleaning up the environment

Role of the consultants

- Assistance of the commune in clarification of sponsorship for the enterprises (EU subvention funds, national, others....)
- Organisation and leading through the training course

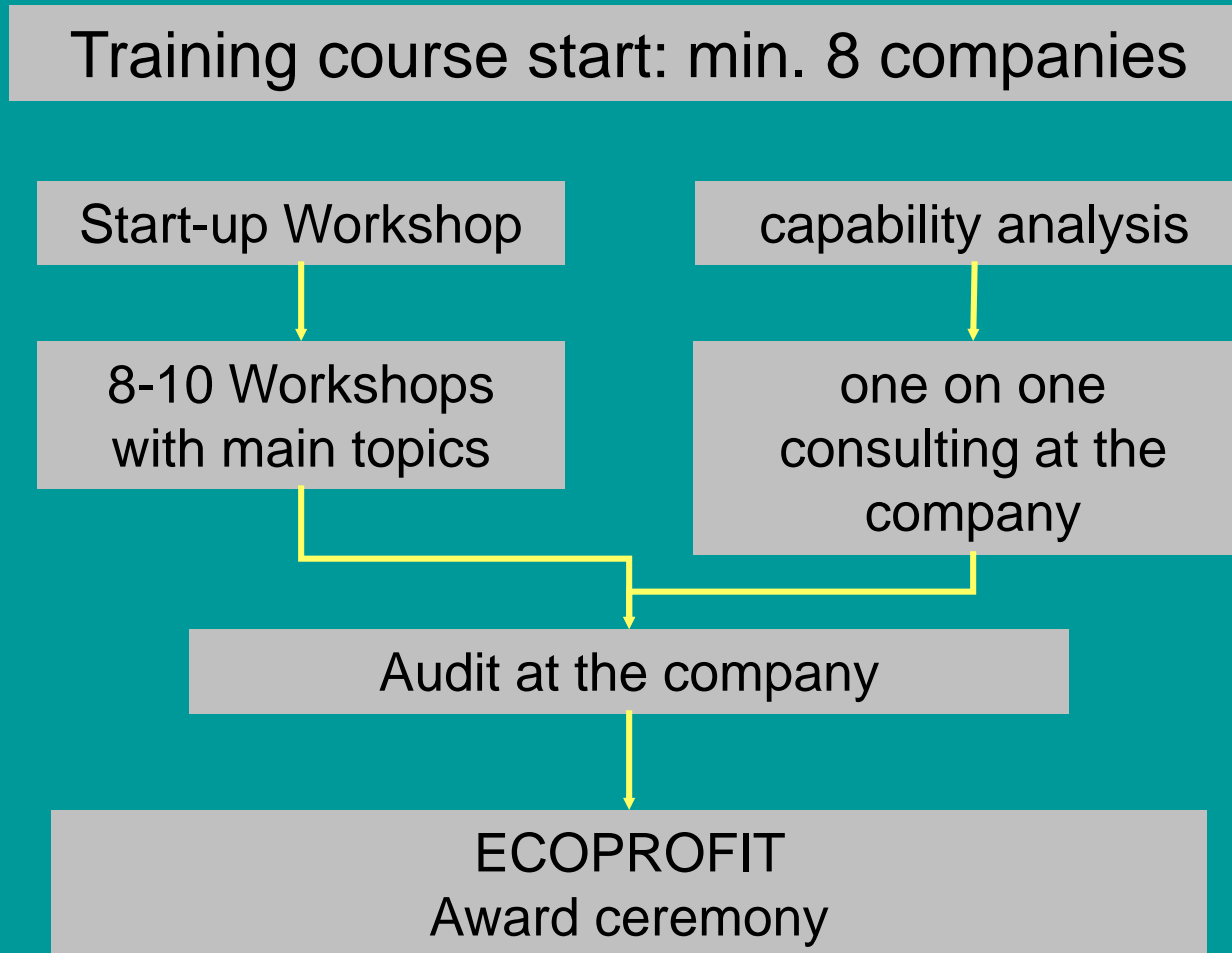

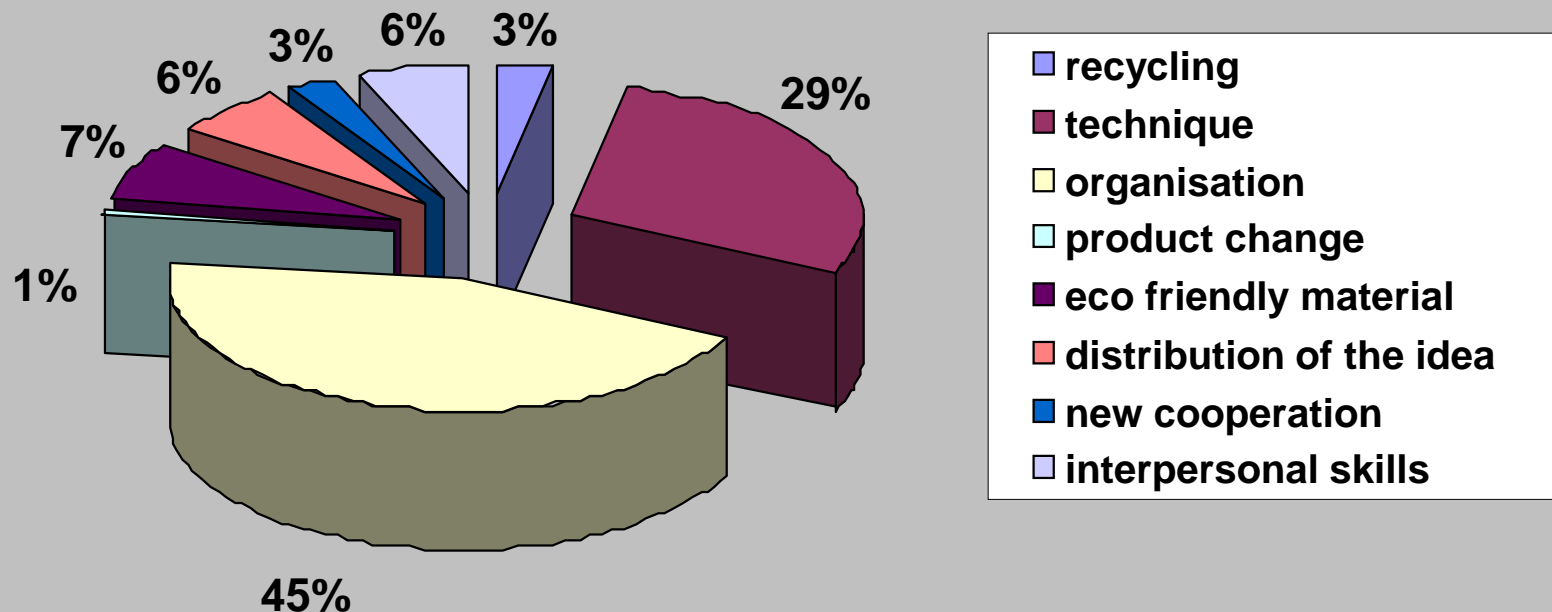
